**INCIDENT: Recovered Shotgun**

**SYNOPSIS OF INCIDENT:**

On the January 2, 2012 at approx. 0140hrs, Bowie Officers responded to 14000 Delcastle Ct. in reference to a disorderly call. Upon arrival Officers discovered that suspects 1-4 were at the above location in reference to a party. A fight ensued at the party and suspects 1-4 fled from the location and were seen minutes later entering a vehicle that was parked in the neighborhood. Suspect # 1 was seen loading a shotgun up once he entered the vehicle. Bowie Officers canvassed the area for the suspects vehicle, the vehicle was located in the area of the 14000 Dahlia Ct. Arrested 1-3 were apprehended and suspect #4 escaped on foot. Officers recovered a loaded shotgun from the vehicle. Names are being withheld pending the arrest of the 4<sup>th</sup> Suspect.
