### SYNOPSIS OF INCIDENT:

On 1/16/2012 at approximately 0805 hours, Bowie Police Officers were dispatched to 3300 Crain Highway, Wal-Mart Superstore, for a report of a commercial armed robbery which just occurred. Upon the Officers arrival, Officers gathered suspect information, set up a perimeter, and canvassed the area. Several Prince George's County Police Officers assisted in the search of the suspects along with their Canine Unit and the Maryland State Police Aviation Department, Trooper 2. An intense search for the suspects provided negative results.

The victim was an employee of Garda Security and was working on-duty; making a pick up of a weekend deposit from the above mentioned Wal-Mart. The victim stated that as he exited the Wal-Mart, a white in color Dodge passenger van pulled up in front of the Garda truck. The victim stated that a black male suspect exited from the van and approached him armed with a black handgun. The suspect demanded that the victim give him the money bag. The victim complied and the suspect fled from the location towards Route 301. The suspect vehicle was later recovered on Mill Branch Road. The vehicle was found unoccupied and revealed a punched ignition. The suspects are currently at large.

Prince George's County CID Unit responded to the scene of the incident and conducted interviews with the victim and witnesses. Prince George's County Police Evidence Unit also responded to the scene of the Wal-Mart and as well as the location of the recovered vehicle. Prince George's County CID will continue the investigation.
