**WHEREAS**, the developer, St. John Properites, Inc. provided securities for permit number SDP 3-0203 to guarantee payment and completion of construction of storm drain, paving and appurtenances at Maryland Science & Tech Center, Block 4, Lot 4; and

**WHEREAS**, the City of Bowie Directors of Public Works and Planning have certified that the work required by the subject permit has been completed according to plans and specifications, as built and release of liens received; and

**WHEREAS**, all requirements of Section 22-34 of the Bowie City Code, concerning approval and acceptance of work, have been fulfilled; and

**WHEREAS**, it is in the best interest of the City to accept the storm drain, paving and appurtenances into the public system:

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Bowie, Maryland, that the City does hereby accept the storm drain system, paving and appurtenances at Maryland Science & Tech Center, Block 4, Lot 4 into the public system and authorizes the City Manager to release the securities provided by St. John Properties, Inc. upon receipt of a one year maintenance bond in the amount of \$876.
