SUBJECT: Resolution R-61-09 Awarding a Contract to Irrigation, Etc.
for Irrigation of the Whitemarsh Park Small Sports Field

On Monday, September 14, 2009, four bid proposals were received to provide and install a fully automatic underground sprinkler system to irrigate turf on the small sports field at Whitemarsh Park. The bids were as follows:

Irrigation, Etc. Glenn Dale, MD	\$14,392.00
Atlantic Lighting & Irrigation Gambrills, MD	\$14,800.00
Long Fence Capitol Heights, MD	\$16,093.00
R.T. MacKenzie, Inc. Burtonsville, MD	\$17,375.00

Upon review of the bids, staff has determined that Irrigation, Etc. submitted the lowest, most responsive and responsible bid. Staff is satisfied that the low bidder, Irrigation, Etc., understands the scope of the work required and is qualified to complete the job. The budgeted amount for this project is \$30,000.00.

Recommendation: Staff recommends the approval of Resolution R-61-09 awarding a contract in the amount of \$14,392.00 to Irrigation, Etc. for the Whitemarsh Park Small Sports Field Irrigation Project.
