Bowie Town Center Basic Plan Amendment (#A-8589-04) – The applicant, Seritage SRC Finance, LLC, is proposing to redevelop the existing 10.81-acre Sears Property with: up to 800 residential dwelling units (multifamily, townhouses (not to exceed 150 units) and/or beds in an assisted living facility); retail uses, including restaurants and shops; a hotel use, with a maximum of 150 rooms; and/or, office uses. The site of subject property is located on the southern side of MD Route 197, and the western and northern sides of Evergreen Parkway. The property is zoned M-A-C (Major Activity Center), where the proposed uses are permitted by right under the Prince George's County Zoning Ordinance. **(EFA - Planning Dept., ext. 3045)**
