A legal notice was placed on eMaryland Marketplace and on the City's website on March 25, 2019 and in the Bowie Blade on March 28, 2019 for the Replacement of the Whitemarsh Park Pedestrian Bridge No. 1 Project. Bids were opened and publicly read on Wednesday, April 24, 2019 at 11am. The following is a tabulation of the bids received:
