Legal notices were placed and bid packages were sent to firms for remedial repairs to the East Coast Greenway Trail located on Route 197 at Mitchellville Road. At the close of bidding at 11:00 a.m., Wednesday, July 24, 2019, four (4) bid proposals had been received as follows:

E & R Services, Inc. Lanham, Maryland	\$33,105.48
Franco's Liberty Bridge, Inc. Clinton, Maryland	\$35,895.00
Crown Construction Service, Inc. Lanham, Maryland	\$48,950.00
HMF Paving Contractors, Inc. Frederick, Maryland	\$53,950.00

This work is being done in accordance with the Capital Improvement Program for Hiker-Biker Trails with a total budget of \$53,000.

The Public Works Department recommends that the bid proposal from E & R Services, Inc., in the amount of \$33,105.48, be accepted. Although this amount is over the FY20 budget of \$164,500, the additional \$9,500 will be paid from the Water and Sewer funding reserves.

I concur with the above recommendation to award to E & R Services, Inc. in the amount of \$33,105.48 and request your approval of R-60-19.
