

## REGULAR CITY COUNCIL MEETING MINUTES

MONDAY, MAY 20, 2019

### CALL MEETING TO ORDER:

The Regular Meeting of the Bowie City Council was held on Monday, May 20, 2019 in the Council Chambers at City Hall. Mayor Robinson called the meeting to order at 8:00 p.m.
