The FY2021 Parks and Grounds Division budget allows for the purchase of one 906M Wheel Loader. The Parks and Grounds Division has located a Contract with the OMNIA Partners/National Intergovernmental Purchasing Alliance Company (Contract #161534-01) through Alban Cat Government Sales, upon which we will be able to piggyback.

This year we have budgeted \$101,000 for this purchase.

The Department of Community Services recommends waiving bidding requirements for good cause shown, as allowed by Section 61(b) of the City Charter, for the purchase of 906M Wheel Loader in the amount of \$78,815.00.
