SPECIAL CITY COUNCIL MEETING MINUTES

TUESDAY, JANUARY 25, 2022

CALL MEETING TO ORDER:

The Special Meeting of the Bowie City Council was held on Tuesday, January 25, 2022 in Council Chambers. Mayor Pro Tem Boafo called the meeting to order at 7:04 p.m.

PLEDGE OF ALLEGIANCE TO THE FLAG:

Mayor Pro Tem Boafo led the Pledge of Allegiance to the Flag.

QUORUM:

In attendance were Mayor Adams (logged in at 7:10 p.m.), Councilmembers Boafo, Esteve, Gardner, Harrison (logged in at 7:10 p.m.), Ndebumadu and Woolfley, City Manager Lott, Assistant City Manager Mears, City Attorney Levan, City Clerk Hernandez.

MOVE TO CLOSE SESSION:

Councilmember Esteve moved to adjourn to closed session under the statutory authority of the Md. Annotated Code, State Government Article §3- 305(b)(7): "To consult with counsel to obtain legal advice". Councilmember Woolfley second the motion. Motion passed 4-0 (Gardner did not vote). Open Session adjourned at 7:06 p.m.

RECONVENE TO OPEN SESSION:

A. Possible consideration of a resolution relating to a proposed settlement of the City's claims in certain federal multi-district litigation concerning the manufacture and distribution of opioid drugs with certain defendants,

Mayor Adams reconvened to Open Session at 7:51 p.m.

City Clerk Hernandez read for the record Resolution R-3-22 Authorizing the City Attorney to Execute National Settlement Agreements with Janssen (Johnson and Johnson) and Certain Opioid Distributors in the Connection with the City's Claims in Certain Multi-District Opioid Litigation.

Councilmember Esteve motioned to adopt Resolution R-3-22. Councilmember Gardner seconded the motion. Motion passed 4-0 (Boafo, Ndebumadu and Harrison did not vote).

Councilmember Esteve moved to adjourn the Special City Council meeting. Councilmember Gardner second the motion. Motion passed 4-0 (Boafo, Ndebumadu and Harrison did not vote). The meeting adjourned at 7:56 p.m.

(15) "To discuss cybersecurity, if the public body determines that public discussion would constitute a risk to: (i) security assessments or deployments relating to information resources technology; (ii) network security information . . . or (iii) deployments or implementation of security personnel, critical infrastructure, or security devices."
