**SYNOPSIS OF INCIDENT:** On 2/23/15 at 1520hrs, Officers responded to the above-listed location for an armed person. Upon arrival, units met with the victim and she stated that she witnessed an adult male, later identified as Marquise Williams, attempting to take two LED lights from the Lowe's home improvement store without paying. The victim approached the arrested while he was leaving the store and advised him that she witnessed him take the property and that she was going to report him to store security. She stated that the male then pointed a black revolver at her and stated "stop following me or I'll shoot you". The male then dropped the stolen items and proceeded to run towards Rte. 197. After a physical description was broadcast, a canvass was conducted and a male fitting the description of the arrested was located walking to the rear of the 3500 block of Crain Hwy. A positive identification was made by the victim and the male was placed under arrest. PGPD K-9 conducted a track for the weapon however none was located. Detective Wuthrich #051 (Bowie CID) interviewed the suspect and the victim at the station then transported the arrested to DOC in Upper Marlboro where he was charged accordingly. There were no injuries in this incident.
