### SYNOPSIS OF INCIDENT:

On 4/10/15 at approximately 2135hrs, Bowie Officers were conducting routine patrol in the 4300 block of Collington Road when Officers noticed a silver/grey colored Toyota displaying expired Virginia tags. Officers conducted a traffic stop on the vehicle. Upon approach from the passenger side of the vehicle, Officers smelled a distinct odor of marijuana coming from inside the vehicle. The driver was identified as a 29 year-old Bowie resident. A search of the vehicle was conducted and Officers recovered multiple baggies of a green leafy substance identified and tested positive as marijuana.

The Bowie resident was placed into custody and transported to Prince Georges County Detention Center for processing.

18.9 grams of marijuana was recovered with a street value of \$378.00

There were no injuries reported.

All events occurred in the City of Bowie, State of Maryland.
