SYNOPSIS OF INCIDENT:

On June 7th, 2015 at approximately 0024 hours, Bowie Police Officers responded to the 12800 block of Beaverdale Lane for a report of an assault which just occurred. Upon arrival, the Officers met with the victim who stated that the suspect was no longer on scene. The victim stated that he had a verbal dispute with the suspect before having what resulted in a physical altercation. The victim stated that the suspect attacked him, stabbing him several times in the back with a metal object. The suspect then fled the area on foot in the direction of Stonybrook Drive.

Officers on scene observed the victim's injuries and requested Prince George's County Fireboard to respond to provide treatment for the victim. Officers on scene gathered witness statements, while additional Officers canvassed the surrounding area for the suspect. The suspect was then located in the 12400 block of Sadler Lane where positive identification of the suspect was made by the victim. The suspect was taken into custody and transported to Bowie Police Department to be interviewed by the Bowie Police Department's Criminal Investigation Division. The suspect was later transported to Upper Marlboro Department of Corrections and charged accordingly.

The victims injuries were non-life threatening; he was treated and released on scene.
