**SYNOPSIS OF INCIDENT:** On 6/11/15 at 0417hrs, Officers responded to the above location in reference to an auto theft in progress. An anonymous caller stated that three males entered a blue pickup truck and were attempting to steal items from it along with the vehicle itself. Upon arrival Officers Moss, Stevens and Williams noticed three males sitting in a red Toyota Avalon in a parking spot behind the blue truck in question. The suspects were ordered to exit the vehicle. During the investigation, there was a large flat head screw driver and a Pioneer radio/CD player located in the vehicle. Further investigation revealed that the Dodge Ram's driver door lock had been damaged. The center console had also been severely damaged along with the ignition. The radio/CD player was missing from the truck and a large rock was discovered on the driver's floor board. The suspects stated that the Toyota they were in belonged to the driver's aunt, who they did not have any information on. An attempt to notify the vehicle's owner, who resides in District Heights, revealed that the Avalon had been stolen from the owner's parking space. The truck's owner was also located at the location and advised of the incident. The suspects were placed under arrest and transported to Upper Marlboro DOC where they were charged accordingly. The owner of the Toyota responded to the scene and recovered her undamaged vehicle. All evidence was recovered and submitted at the Bowie Police Departments Evidence room.
