**SYNOPSIS OF INCIDENT:**

On August 11, 2015 at 1446hrs, Officers Redmond and Magnuson were on patrol in the area of the 6800 Block of Race Track Road. Both Officers were alerted by the victim that he and a friend were just assaulted at gun point by two subjects in the rear of the 13000 Block of Marquette Lane. Further investigation revealed that both victims #1 and #2 were in the rear of the 13000 Block of Marquette Lane when both arrested #1 and #2 walked up to them and a verbal and physical altercation occurred over marijuana. Arrested #1 produced a handgun and pointed it at victim# 2; all of the involved people then fled on foot in opposite directions. Officers canvassed the rear parking lot area of the 13000 Block of Marquette Lane. Officers observed Arrested # 1 pass a handgun to Arrested #2 at which time he threw the weapon into the wood line area behind Hilltop Shopping Center and attempted to flee the location. After a short foot pursuit, both of the arrested subjects were apprehended. A silver 9mm loaded handgun was recovered at the scene. Arrested #1 is a juvenile but was charged as an adult due to the nature of the charges. No injuries occurred.
