### SYNOPSIS OF INCIDENT:

The aunt was present in the home during this incident and place herself between the victim and the arrested, she was also able to get the knife away from the arrested prior to the arrival of Bowie Police Officers. After all information was collected by Officers, the arrested was placed into custody and transported to Bowie Police Department for processing and then to a Department of Juvenile Justice intake facility.
