**SYNOPSIS OF INCIDENT:**

On 09/05/15 at approximately 2206 hours, Bowie Units responded to the 4000 block of Chelmont Lane for the report of an injured woman. Upon arrival, Officers attempted to speak with the victim who was bleeding from the head and uncooperative. Further investigation revealed that the victim was assaulted by her husband. The suspect did choke and strike the victim in the face with a hard blunt object leaving a scar above the victim's left eye. Prior to the arrival of Bowie Police Officers, the suspect fled the scene in a late model Dodge Dakota pick-up truck. A canvass for the suspect was conducted and there were negative results. An arrest warrant was obtained for the suspect. Warrant D141118762 was issued for 1<sup>st</sup> and 2<sup>nd</sup> degree assault. The victim's injuries were not life threatening.
