SYNOPSIS OF INCIDENT:

On 11/13/15 at approximately 2008hrs, Bowie Units responded to the 2900 block of Trainor Lane for a panic alarm coming from inside Tulip Grove Elementary School. Upon arrival, Bowie Officers observed multiple broken windows inside and around the school. In addition, there was a cloudy mist coming from inside the school. Bowie Officers noticed a fire extinguisher laying on the floor near the front entrance hallway of the school that had been discharged. An area canvass was conducted immediately around the school, and upon reaching the rear of the school, Bowie Officers discovered 4 juvenile males in the rear of the school wearing black hats and black gloves. Upon speaking with the juvenile males and further investigation on scene, it was determined the 4 juvenile males had entered the school without permission through a broken window. All 4 juvenile males were placed into custody and transported to Bowie Police Department for processing and to be interviewed by Bowie Police C.I.D.

There were no injuries to the arrested.

All events occurred in the City of Bowie, Prince George’s County, State of Maryland.
