**SYNOPSIS OF INCIDENT:**

On December 8, 2015 at 0015hrs, Bowie Officers were dispatched to 15207 Major Lansdale Blvd (Friday's Restaurant) in reference to a possible citizen robbery. The suspect fled the location in a dark color sedan, possibly armed with an unknown caliber handgun. Bowie Officers located a vehicle matching the description in the 2400 block of Kenhill Drive and initiated a traffic stop.

Bowie Officers detained the driver and passenger of the vehicle and conducted a search. Officers recovered a loaded 40. Caliber JCP handgun and 167 grams of suspected Marijuana from the vehicle. Further investigation revealed that the suspect (Driver) and a patron got into an argument over a missing cell phone, which prompted the initiated call. Both Bowie CID and PGC NED were notified of the incident. The listed property was recovered and submitted to the Bowie Property Section and PGPD District 2 Property Section. The suspect was placed under arrest and transported to Bowie PD/ DOC for processing.
