SYNOPSIS OF INCIDENT:

On 4/25/16 at approximately 1837hrs, Bowie Units responded to 4100 block of Chelmont Lane for the report of a fight in progress behind Samuel Ogle Middle School. The investigation revealed that the suspects assaulted the victim and stole his cell phone. Officers began an area canvass and the three suspects were observed walking near the intersection of Laurel Bowie Road (MD Route 197) and Maddox Lane. Upon approach, all three suspects ran in different directions. Additional Bowie Police Units, as well as Prince George’s County Police, PGPD K-9, and the PGPD Aviation Unit assisted in the apprehension of all three suspects after a brief foot chase. The suspects were placed into custody and transported to Bowie Police Department for further investigation and processing.

The arrested males suffered no injuries in reference to this incident.
