### SYNOPSIS OF INCIDENT:

On 06/06/2012 at approximately 0300Hrs, Bowie Police Units responded to 3637 Elder Oaks Blvd for a report of a Home Invasion/Shooting. Upon arrival, Bowie units met with the Victim who advised that four (4) Suspects ambushed him at his front door, forced him into his home, duct taped his hands and feet and stole approximately \$20,000 in U.S. Currency hidden in his home. The Victim then advised that he was able to free himself from the tape, at which time he pursued the suspects in his vehicle. While pursuing the Suspects in his vehicle, the Victim states that the Suspects observed him, and fired shots from a handgun at him, striking his vehicle in the front hood, windshield and rear passenger window. There were no reported injuries associated with this incident. Bowie Police Units Canvassed the area of the reported shooting with negative results. The Prince George's County Police Robbery Unit Responded to the scene and assumed the investigation.
