SYNOPSIS OF INCIDENT:

On June 11, 2012 at approximately 2211 hours, Bowie Units responded to the 15600 block of Everglade Lane for the report of an armed robbery. Upon arrival, the victim's mother stated that her son had been robbed at gunpoint by an unknown suspect in front of their residence approximately one hour earlier. Her son had initially left the scene but when he returned, he stated that he and his brother were sitting on a bench in front of their building when an unknown suspect walked up to them and asked them for a cigarette. After they replied that they did not have a cigarette, the suspect walked away. The suspect then returned and displayed a silver handgun and pointed the weapon towards the victim. He then told the victim to give him money. The victim handed his wallet to the suspect. After the suspect got the wallet, he told the victim and his brother to start running as he pointed the gun in their direction. They both ran from the area and the suspect was last seen running towards the rear wooded area between 15606 and 15604 Everglade Lane. Taken from the victim were his identification and two prepaid Visa Cards.

Bowie CID Detective's Polk and Wood responded to the scene to assume the investigation.
