SYNOPSIS OF INCIDENT: On 11/2/16 at 1550 hrs, Bowie Officers responded to the above-listed location in reference to a citizen armed robbery. Upon arrival, the victim stated that while he was at the ground floor checking his mailbox, he was approached by two individuals. Both the male and female suspects were wearing black hooded sweatshirts and camouflage pants. The male displayed a black automatic handgun and demanded the victim to “empty your pockets”. The victim complied and the female suspect took the victim’s cell phone from his rear pants pocket. A wallet and a 2nd phone were also taken. The suspects then fled to an unknown destination.

The victim’s i-Phone was equipped with a locating device which was used to track its location. The cell phone was tracked to the 800-900 Capital Center Blvd. where P.G. County Police units assisted in the canvass. Both suspects were eventually located at 821 Capital Center Blvd. They were placed under arrest and transported to the Bowie Police Station where they were interviewed. Both individuals were then transported to Upper Marlboro DOC for processing.
