Today's COVID Brief

19.3% (+0.5%) of the total U.S. population and 62.4% (+1.2%) of the population 65 and older has received at least 1 dose of vaccine. Despite big progress this week, Prince George's County has the lowest percentage of residents fully vaccinated among Maryland jurisdictions, with only 5.16% of county residents having received both doses of the Pfizer/Moderna vaccines and 0.72% having received the Johnson & Johnson vaccine.

County Takes Some Steps Toward Reopening

Prince George's County Executive Angela Alsobrooks announced yesterday that the County is expanding COVID-19 capacity limits for businesses and other establishments due to a continued and significant decline in the County's positivity rate and other key COVID-19 metrics, and due to increasing vaccination rates in the

County. While these changes do not go as far in reopening as the Governor's orders, they reflect a major step in recovery, based on current conditions in Prince George's County.

The updated safety measures will take effect today, Friday, March 12, 2021, at 5 p.m.

Under the County's updated Phase 2 guidelines, businesses and other establishments will be able to reopen or expand current capacity limits, including:

- **Restaurants:** Indoor and outdoor dining is allowed at 50% of maximum capacity. Restaurants must ensure social distancing and mask-wearing is observed.
- **Theaters:** May reopen at 50% of maximum capacity.
- **Gyms/Fitness Centers:** May expand to 50% of maximum capacity. Face coverings must be worn over the nose and mouth when working out.
- **Banquet Halls, Receptions & Meeting Rooms:** May expand to 50% of maximum capacity, applicable to the specific room where the event will be held.
- **Houses of Worship:** Indoor services may expand to 50% of maximum capacity, with social distancing requirements in place. Outdoor services are allowed up to 50% maximum capacity of the outdoor area, with social distancing and access to hand washing or hand sanitizers in place. Masks must be worn.
- **Personal Services:** May expand to 50% of maximum capacity. These establishments must operate by appointment only.
- **Retail:** May expand to 50% of maximum capacity.

Businesses and other establishments must continue following all other safety guidelines, including the enforcement of wearing masks and social distancing. In addition, unless otherwise expressed in the Executive Order, indoor gatherings are limited to a maximum of 20 persons and outdoor gatherings are limited to a maximum of 50 persons. A full list of updated guidelines, as well as a copy of the Executive Order, will be available at mypgc.us/reopen.

City staff will evaluate the County's new executive order and make announcements soon about how these new directives will affect city operations and facilities

Other Announcements from the Prince George's County Press Conference on March 11

COVID Metrics:

- New cases have trended down to approximately 1,000 per week.
- The average case rate is 16 per 100,000, which is still a high rate, but this is a tremendous improvement over January rates. (On January 8, the rate was 58.8 per 100,000, which was four times as high as the current rate.)
- The positivity rate is now at 4.3% and has remained in the 4% range for the last two weeks.
- The infection rate is under one, which means the virus is finally spreading more slowly.
- For the first time in four months, there are less than 100 COVID hospitalizations in the County.
- The Health Department clinic at the Sport and Learning Center will close temporarily from March 13 – 28 for maintenance but will reopen on March 29. New clinics will open at community centers in Seat Pleasant and Landover.

Vaccinations:

- One third of county residents over the age of 65 have received at least one dose.
- The County Health Department is now administering approximately 14,000 shots per week at its clinics. Only two other local health departments in the state are administering more vaccines per week.

- Last week, over 31,000 Prince George's County residents received vaccinations at a pharmacy, mass vaccination site, health department clinic, or other location.
- County officials are also partnering with retail pharmacies like Wegmans and Walmart to hold closed clinics. The appointments are being scheduled with eligible individuals who are on the County's pre-registration list.

Face Coverings:

- The County Face Covering Order remains in place.
- Masks must be worn by those age five and up whenever they leave home.
- The order applies both indoors and outdoors. The only exception is that masks need not be worn outdoors during rigorous exercise.
- Masks must cover the nose **and** mouth.

Governor Announces Easing of COVID Restrictions but Will Keep Mask Mandate

Governor Hogan held a press conference on March 9 to report on the state's progress in managing the COVID-19 crisis and to announce the lifting of certain mitigation measures that have been in place for several months.

The Governor announced the following changes **effective Friday, March 12 at 5 p.m.**

- **Capacity limits** will be lifted on outdoor and indoor dining. Restaurants and bars will still be limited to seated and distanced service only.
- **Capacity limits** will also be lifted on retail businesses, religious facilities, fitness centers, personal services, and indoor recreational establishments, (casinos, bingo halls, bowling alley, and skating rinks).
- **Large indoor and outdoor venues** will be permitted to operate at 50% capacity. This includes conference and wedding venues, concert venues, conventions, theaters, racing facilities, and sporting venues, such as Camden Yards and Pimlico.
- **Masking, physical distancing, and other safety protocols will remain** in place for all indoor and outdoor business and establishments.
- **Out of state travel** restrictions and quarantine requirements will also be lifted.
- **The Maryland Department of Health Travel Advisory** will remain in place and will continue to encourage Marylanders to get tested when they return from travel.
- **Medical Adult Daycare Centers** will also reopen if the facilities are able to manage appropriate restrictions and safety measures.
- **Telework should continue.** With contact tracing continuing to show transmission among individuals working in office settings, employers are encouraged to continue supporting telework when possible.

Vaccine supplies are expected to remain at current levels for the next couple of weeks, but then should be more plentiful as production ramps up. State and county officials are working together to bring approximately 10,000 priority appointments per week to Prince George's County residents statewide. Governor Hogan encouraged all jurisdictions to follow his Executive Order but acknowledged that local jurisdictions could choose to keep more restrictive measures in place. He concluded his remarks by saying "the statewide masking order in Maryland remains in full force and effect." He urged continued vigilance: "Let's continue to be smart. We can't afford to undo all the tremendous progress that we have made together."

Are You Pre-Registered to be Vaccinated?

Last night, President Biden announced that he will direct states to open vaccinations to all residents, age 18 and up, by May 1. How this will actually work remains to be seen, but it would seem to assume that vaccine supplies will increase substantially and that great progress will be made between now and then on vaccinating priority groups, including those age 65 and up. What we do know now, is that it is more important than ever for every adult to plan to get vaccinated. Consider where you would be willing to receive your vaccination and then pre-register if you can.

The Prince George's County pre-registration list is an important tool for all county residents to use in securing vaccinations. No matter what phase you fall in for vaccinations, it's time to get on Prince Georges County's pre-registration list. Not only is the list being used to schedule appointments at health department clinics, it is now being used as well to schedule priority appointments at the state's Six Flags mass vax site, and at some of the closed clinics that retail pharmacies and other community partners are conducting to help get Prince Georgians vaccinated. According to an announcement from the Governor's office, these efforts will bring 10,000 priority appointments per week to county residents.

Some hospital systems also have their own pre-registration lists. For now, it makes sense to pre-register wherever you can. Remember pre-registration and scheduling appointments are different processes and you are not gaming the system by using multiple approaches to securing an appointment. You should take whatever appointment opportunity you receive first and decline all other appointment offers in the future and then remove your name from other pre-registration lists.

CDC: When You've Been Fully Vaccinated

The Centers for Disease Control and Prevention (CDC) released [new guidance for people who have been fully vaccinated](#). People are considered fully vaccinated two weeks after their second dose of Pfizer or Moderna vaccines, or two weeks after the single-dose Johnson & Johnson vaccine.

Fully vaccinated people:

- Can visit indoors with fully vaccinated people without wearing a mask or keeping their distance.
- Can visit with unvaccinated people from one other household (for example, visiting with relatives who all live together) without masks or physical distancing, unless any of those people or anyone they live with has an increased risk for severe illness from COVID-19.
- Do not need to stay away from others or get tested after exposure to someone with COVID-19 unless they develop symptoms.


The CDC guidance says that everyone, even those fully vaccinated, should:

- Take precautions in public like wearing a well-fitted mask and physical distancing
- Wear masks, practice physical distancing, and adhere to other prevention measures when visiting with unvaccinated people who are at increased risk for severe COVID-19 disease or who have an unvaccinated household member who is at increased risk for severe COVID-19 disease
- Wear masks, maintain physical distance, and practice other prevention measures when visiting with unvaccinated people from multiple households
- Avoid medium- and large-sized in-person gatherings
- Get tested if experiencing COVID-19 symptoms
- Follow guidance issued by individual employers

Phase 1 Vaccine Appointment Options

Visit the [Maryland Vaccination Locator site](#) for links to the more than 270 vaccination sites in the state. We have also provided direct links to each of the organizations administering vaccinations below. Each organization providing vaccinations has its own appointment process and even the mass vaccination sites for the state have different registration processes, depending on who the medical partners for the different sites.

1. **Prince George's County Health Department Facilities** – Requires [pre-registration](#). When an appointment is available you will receive an email inviting you to schedule your appointment. Efforts remain focused getting those in Phase 1A and 1B vaccinated. They county hopes to begin scheduling Phase 1C appointments sometime in March.*
2. **Hospital systems** – [University of Maryland](#), [Luminis](#), [MedStar](#), [Johns Hopkins](#), [Holy Cross Hospital](#), and [Adventist](#) are offering appointments as supplies permit.
3. **Retail pharmacies**, such as [Giant](#), [Safeway](#), [CVS](#), [Rite Aid](#), [Walgreens](#) and [Walmart](#).
4. **Maryland Mass Vaccination Locations** – [Six Flags](#), [M & T Bank Stadium](#), [Baltimore Convention Center](#), and [Regency Furniture Stadium in Waldorf](#).
5. **Vaccination clinics at houses of worship and other community locations** – As part of state and county efforts to improve racial disparities in vaccine distribution, vaccinations will also be done at Reid Temple in Glenn Dale and First Baptist Church of Glenarden (at their Upper Marlboro center) and other community based locations. Healthcare partners are providing the medical support at these clinics.)

There are also targeted efforts to vaccinate seniors and other vulnerable populations in their communities with the help of mobile vaccination units.

The [Maryland Vaccination Locator website](#) provides links to each of the vaccination appointment options listed above. At this time, the appointment scheduling process remains decentralized. You must click on a specific vaccination site to determine if they have vaccine appointments available.

(* *Pre-registration on the Prince George’s County Health Department vaccination website adds you to the waiting list for an appointment at a Prince George’s County Health Department site. It does not pre-register you for appointments at retail pharmacies or at hospital system facilities.*
