



**Search Warrant/ Residential Burglary Arrest**

**SYNOPSIS OF INCIDENT: On 11/27/12, PFC Wuthrich of the Directed Response Team, was conducting an investigation into several citizen complaints of drug distribution in the "P" Section of the City. PFC Wuthrich checked the suspect's name in the LInX database, where he discovered that the suspect had recently pawned jewelry that was inscribed with a name different than his own. Recent burglary reports were reviewed, and the name inscribed in some of the jewelry matched the name of a burglary victim in the 1100 block of Pennypacker Lane, from 10/25/12. Pawn records were retrieved and a search and seizure warrant was obtained and executed on the morning of 11/26/12 at 1109 Patriot Lane. Recovered during the search was additional jewelry that was taken in the burglary of the home on Pennypacker Lane, as well as approximately 25 grams of marijuana, which was individually packaged for street sales. Other paraphernalia, such as a digital scale and glassine baggies, were also recovered. The suspect was on scene and was brought to the Bowie Police Station, where during an interview; he admitted his involvement in the burglary. He was taken to Upper Marlboro DOC where he was charged accordingly. His involvement in other burglaries is being investigated.**
