



**INCIDENT:** Commercial Armed Robbery

**LOCATION:** 13811 Old Annapolis Rd. **LOCATION TYPE:** Gas Station

**SYNOPSIS OF INCIDENT:**

On May 23, 2013 at approximately 1915 hours, Bowie units responded to the Shell Gas Station located at 13811 Old Annapolis Road for an armed robbery that had just occurred. Upon arrival, Victim advised that an unknown black male entered the store, pointed a gun at him and demanded money.

The Victim handed over the money, and the Suspect then ran out of the store towards Church Road. The Victim advised that he chased after the unknown black male and saw him run south bound on Church Road towards Westview Forest Drive. The Victim advised that the unknown black male was wearing a black shirt, black cap, and blue jeans.

Bowie units conducted an area canvass and found a black t-shirt and a black baseball cap in the 4500 block of Church Road. A witness was located and they advised that they saw a unknown black male running from the Shell Gas Station south bound on Church Road towards Westview Forest Drive and into the back yard of a house. Prince George's County Crime Scene Investigators responded and processed the scene. Prince George's County K-9 (T-112) was also notified for a track, which ended in negative results. Prince George's County Robbery Unit was contacted, Sergeant Robinson (ID 2563) responded and took over the investigation.

All events occurred in the City of Bowie, Prince George's County, Maryland.
