

INCIDENT: Home Invasion

LOCATION: 15200 Block Jennings Lane – Bowie LOCATION TYPE: Single Family Home

DATE & TIME OF INCIDENT: 6/17/2013 / 2303 HOURS

SYNOPSIS OF INCIDENT: On June 17, 2013 at 2303 hours, Bowie Police responded to the 15200 block of Jennings Lane for a report of a home invasion robbery. Once on scene, Officers learned that Victim 1 received a call from an unknown individual who stated that he wanted to set up a drug transaction at the victim's residence. A short while later, an unknown individual rang the doorbell of Victim 1's home. Victim 1 then answered the door but found no one there. He then observed the two suspects running toward him from the side of his residence. Victim 1 attempted to run back into his home and shut the door but was unsuccessful. Both suspects entered the residence and Suspect 1 produced a silver handgun. The suspects then began to physically assault Victim 1 asking multiple times "Where's it at?" One of the suspects then went upstairs where he encountered Victim 2 and held her at gunpoint. Victim 1 stated that fourteen "dime" bags of marijuana were taken by the suspects who then fled the scene on foot to the rear of the residence. Bowie officers set up a perimeter around the area and Prince George's County K-9 units arrived on scene to conduct a K-9 track for the suspects. Prince George's County air support was also on scene to assist with the search for the suspects. All yielded negative results. Prince George's County evidence technicians responded to and processed the scene. Prince George's County Robbery Unit Detective Woods (3150) also responded to the scene and will be conducting the follow-up investigation. Victim 1 sustained serious facial trauma as a result of the assault. Victim 2 sustained minor injuries. Both victims were transported to Prince George's County Hospital for medical treatment. Nothing further at this time.
