



**INCIDENT: Vandalism**

**LOCATION: 14900 Health Center Drive & 15901 Excalibur Road, Bowie, Maryland, 20716**

**DATE & TIME OF INCIDENT: 06/24/2013 / 0130-0300 Hrs**

**SYNOPSIS OF INCIDENT: On June 24, 2013 at 0303 hours, Bowie officers were dispatched to a call for disorderly conduct at the Bowie Senior Center located at 14900 Health Center Drive Bowie, Maryland, 20716. Once on scene, Officers spoke to the witness who was a security officer for the nearby apartment complex. He stated that two individuals arrived in the area in a burgundy Chevrolet Astro style work van. One suspect exited the vehicle and proceeded to spray paint a symbol resembling a cross overlaid with a fish on numerous City of Bowie vehicles. The witness then stated that when the suspects became aware of his presence, they fled the area in the direction of Route 50 Eastbound.**

**Further investigation revealed that the suspects also vandalized numerous City vehicles and Bowie City Hall itself at 15901 Excalibur Road, Bowie, Maryland, 20716. The same symbol from the Senior Center vandalisms was present at this scene as well. An area canvas was conducted for the suspect vehicle with negative results. Numerous photographs were taken of the vandalized property. The scenes were also processed for latent prints with negative results. Nothing further at this time.**
