



**INCIDENT: Possession of a Handgun**

**SYNOPSIS OF INCIDENT:**

On August 27, 2013 at approximately 1339 hours, Bowie Officers responded to the area of the Shell Gas Station located in the 13000 block of Old Annapolis Road for a report of two suspicious looking juvenile males. The citizen caller stated that they were wearing dark colored clothing looking into vehicles in the area. Officers conducted an area check for these individuals. Officers then observed two individuals matching the description at 6100 block of High Bridge Rd. The two juvenile males were stopped, when approached by the officers and asked what were they doing there, the officers noticed that the two juveniles had black ski masks in their possession. Officers then conducted a pat down for weapons on the two juveniles. A .38 caliber "snub nose" revolver was recovered on one of the males and a "Black Barracuda Stun Gun" on the other male. Both were immediately placed into custody and transported to Bowie Police Department to be interviewed and processed. Det. Wuthrich #051 (Bowie P.D.) and Det. Maxwell #2840 from Prince Georges County Police responded. Department of Juvenile Services was notified of this incident and both suspects were issued detainers and transported to Cheltenham Juvenile Correctional Facility.

All events occurred in the City of Bowie, Prince George's County, and State of Maryland.
