



**INCIDENT: Citizen Robbery (Attempt)**

**LOCATION: 15200 Major Lansdale Boulevard, Bowie, MD, 20716**

**LOCATION TYPE: Movie Theater**

**DATE & TIME OF INCIDENT: September 13, 2013 / 2027 Hours**

**SYNOPSIS OF INCIDENT:** On September 13, 2013 at 2054 hours, Bowie officers responded to the 12300 block of Firtree Lane, Bowie, Maryland, 20715 for a report of an assault victim. Once on scene, officers spoke to the victim who advised that he had been assaulted at the Regal Movie Theater located at 15200 Major Lansdale Boulevard, Bowie, Maryland, 20716. The victim seemed very disoriented during the investigation possibly due to injury received during the assault. After an extensive investigation, officers were able to ascertain that the victim had been dropped off at the movie theater to meet up with friends. While there he was approached by three suspects, one of which he recognized as an individual named "Bryce." According to the victim, "Bryce" asked him if he wanted to buy marijuana. The victim stated that he did not. The Suspect attempted to take the victim's cellular phone from his pocket. The victim resisted and was struck in the face. While attempting to fight back, the victim was struck in the head by one of the other individuals with "Bryce." The victim stated that he did not remember what happened after that. Detective Wood 055 with Bowie CID was notified and responded to the scene. Given the large time lapse between the time of incident and when officers were able to find out what occurred Prince George's County K-9 unit could not deploy. Bowie CID will conduct the follow-up investigation.
