



**INCIDENT: Citizen Armed Robbery**

**LOCATION: 300 Block of Jersey Court, Bowie, Maryland, 20716 LOCATION TYPE: Park**

**DATE & TIME OF INCIDENT: September 13, 2013 / 2032 Hours**

**SYNOPSIS OF INCIDENT: On September 13, 2013 at 2038 hours, Bowie Police responded to a call for a citizen armed robbery in the 300 block of Jersey Court, Bowie, Maryland, 20716. Once on scene officers learned that the victims had been smoking at the playground to the rear of the homes in the 300 block of Jersey Court. Two unknown males dressed in all black emerged from the bushes and approached the victims at which point they produced a handgun and a machete which were pointed at the victims. V3 and V4 fled the scene on foot. The suspects then demanded property from V1 and V2 which they received and fled the scene on foot. Their last known direction of travel was toward Central Avenue. Bowie Units conducted an area canvass for the suspects with negative results. Prince George's County K-9 and Air One units were requested but were unable to respond as they were tied up on other calls. Detective Wood #055 responded to the scene. Bowie CID will conduct the follow up investigation.**
