

**INCIDENT:** Armed Citizen Robbery (Arrest)

LOCATION: 4000 Block Chelmont Lane – Bowie, MD LOCATION TYPE: Street

## SYNOPSIS OF INCIDENT:

On September 25<sup>Th</sup>, 2013 at approximately 1830 hours, Bowie Police Units were dispatched to the 4000 block of Chelmont Lane for a report of a citizen armed robbery which just occurred. Upon arrival Officers met with the victims, gathered suspect information and collected evidence from the scene of the incident. Bowie Officers canvassed the area for the suspect. According to the victims, the suspect approached the victims, brandished a black handgun and made verbal demands. The suspect fled in a vehicle and made good of his escape with \$25 in U.S. Currency.

At approximately 2049 hours, a felony traffic stop was conducted on a vehicle matching the description of the suspect vehicle. After the occupants were removed from the vehicle and the stop was made safe, the victims were transported to the location of the traffic stop where a positive identification of the suspect of the armed robbery was made. The suspect was taken into custody and transported to the Bowie Police Station where he was interviewed by Bowie Police Criminal Investigation Division. After a written statement of the incident was obtained, the suspect was transported to Upper Marlboro Department of Corrections where he was charged with Armed Robbery and 1<sup>St</sup> Degree Assault.

The victims were not injured during the robbery.
