SYNOPSIS OF INCIDENT:

ON 10/21/13 AT APPROXIMATELY 1230HRS, BOWIE UNITS RESPONDED TO THE AREA OF TWISTING LANE AND TWIN CEDAR LANE FOR THE REPORT OF AN ARMED CITIZEN ROBBERY. ONCE AT THAT LOCATION, THE VICTIM REPORTED THAT HE WAS WALKING ON THE TRAIL PATH, WHEN A MALE SUSPECT CAME UP FROM BEHIND HIM AND DEMANDED HIS BACKPACK. THE SUSPECT WAS WEARING A SKI MASK AND DISPLAYED A BLACK HANDGUN. THE VICTIM COMPLIED WITH THE SUSPECT AND GAVE HIM HIS BACKPACK WHICH CONTAINED NUMEROUS PRESCRIPTION DRUGS AND CASH. THE SUSPECT THEN FLED IN AN UNKNOWN DIRECTION.
