



INCIDENT: Commercial Burglary (Arrest)

LOCATION: 3300 Block of Northview Drive, Bowie, Maryland, 20716

LOCATION TYPE: Boat House (Allen Pond)

DATE & TIME OF INCIDENT: October 26, 2013 / 0303 Hours

SYNOPSIS OF INCIDENT: On October 26, 2013 at 0303 hours, PFC Gonzalez and P/O Simmons observed A1 and A2 dressed in all black walking along Northview Drive heading toward the foot bridge that crosses over Collington Road. The Officers attempted to make contact with the individuals at which point A1 began to flee. A short foot pursuit resulted in A1 being detained in the 15200 block of Major Lansdale Boulevard. A2 was detained at the original location of contact. When asked why he ran, A1 began to advise officers that he and A2 had attempted to break into the boat house located at Allen Pond in the 3300 block of Northview Drive. At this point A1 was placed under arrest and advised of his rights by PFC Curry. After waiving his rights A1 continued to explain that he and A2 had used a hammer to break into the boat house in an attempt to steal property and money. When they realize that they had entered a storage closet A1 and A2 ceased their efforts and left the scene. A1 also showed Officers the burglary tools that he had in his back pack which consisted of a hammer, flashlights, screwdrivers and gloves. Officers responded to the boat house at Allen Pond and observed heavy damage to the side storage closet door that was consistent with A1's story. The scene was photographed by PFC Booth. Both A1 and A2 were then transported to the City of Bowie Police Department where A2 was advised of his rights. He then completed a written statement of his account of the incident. A1 refused to make a written statement. Both A1 and A2 were processed and released to their parents. Nothing further.
