



**INCIDENT: CRITICAL INCIDENT**

**LOCATION: 15300 Emerald Way, Bowie MD (Macy's Department Store – Bowie Town Center)**

**DATE & TIME OF INCIDENT: November 19, 2013 @ 1730 Hrs.**

**SYNOPSIS OF INCIDENT:**

On November 19<sup>th</sup>, 2013 at approximately 1730 hours, Bowie Police Officers were conducting a premise check of the Bowie Town Center. At that time, PFC Neal (I.D. #0048) observed a Macy's loss prevention officer struggling in a physical altercation with a subject in the parking lot outside of the Macy's department store. PFC Neal provided assistance to the loss prevention officers and the subject was taken into custody for a suspected theft of merchandise from the Macy's department store.

The suspect was placed into custody of police officers on scene. The total for the amount of clothing and merchandise stolen from Macy's was \$3,523.46; all merchandise was recovered. Prior to being transported, Officers conducted a search of the subject. During the search, a suspected grenade, which was wrapped in a plastic bag, was recovered from the subject's back pack. The device was removed from the store to an outside parking lot. Prince George's County Fire Department and their Bomb Squad, along with K-9 units, responded to the location. A command center was established and Bowie Police Department's Deputy Chief Preston was on scene of the incident. At approximately 2230, hours it was determined that the device was non-explosive. The incident concluded and the subject involved was transported to the Bowie Police Department. The subject was transported to Upper Marlboro Department of Corrections where he was charged accordingly. There were no reported injuries as a result of this incident.
