



**INCIDENT: CITIZEN ROBBERY (HANDGUN)**

**LOCATION: 3900 BLOCK OF WOODHAVEN LANE LOCATION TYPE: CITY STREET**

**SYNOPSIS OF INCIDENT:**

ON 11/15/13 AT APPROXIMATELY 1916HRS, BOWIE UNITS RESPONDED TO THE 3900 BLOCK OF WOODHAVEN LANE FOR A REPORT OF AN ARMED ROBBERY. ONCE AT THAT LOCATION, BOWIE UNITS MET WITH THE VICTIM WHO REPORTED THAT HE WAS WALKING IN THE AREA OF THE 3900 BLOCK OF WOODHAVEN LANE , WHEN THREE UNKNOWN BLACK MALES JUMPED OUT OF A VEHICLE AND DISPLAYED A BLACK HANDGUN.
