



INCIDENT: STRONG ARMED ROBBERY

LOCATION: 3900 BLOCK OF EVERGREEN PARKWAY LOCATION TYPE: PUBLIC EATERY

SYNOPSIS OF INCIDENT:

ON 11/15/13 AT APPROXIMATLY 2040 HOURS, BOWIE UNITS RESPONDED TO THE 3900 BLOCK OF EVERGREEN PARKWAY FOR A REPORT OF A CITIZEN ROBBERY. ONCE AT THAT LOCATION BOWIE UNITS MET WITH THE VICTIM WHO REPORTED WHILE HE WAS SITTING IN THE CALIFORNIA TORTILLA WHEN FIVE UNKNOWN BLACK MALES APPROACHED HIM AND ASKED "IF HE HAD ANY MONEY". WHEN THE VICTIM STATED TO THE SUSPECTS THAT HE DIDN'T HAVE ANY MONEY, THE SUSPECTS THEN TOOK HIS SKATEBOARD VALUED AT \$200. THE SUSPECTS THEN FLED ON FOOT IN AN UNKNOWN DIRECTION OF TRAVEL.

AN AREA CANVASS WAS CONDUCTED WITH NEGATIVE RESULTS.

NO INJURIES WERE REPORTED.
