SYNOPSIS OF INCIDENT: On 7-17-14 at approximately 1644 hours, Bowie Police received a call at Allen Pond Park for black male wearing black jeans, black tee shirt, and a backpack exposing himself in the park. Upon arrival, CPL Shifflett observed the Arrested, matching the suspect description, exiting the park on the Nottinghill Drive side. The Officer exited his cruiser and approached the Arrested. The Arrested began to act nervous by looking around repeatedly, stepping side to side (small steps) as if he was preparing to run, and sweating profusely. The male was asked to sit on the ground and a frisk of his person and backpack was conducted. The Officer then felt the butt of a handgun through the backpack. The backpack was removed and unzipped at which time the Officer observed the butt of a handgun. The Arrested was taken into custody. PFC Neal found a second handgun in the backpack as well as a clear plastic baggie containing green leafy substance (suspected marijuana) and another loaded magazine. After clearing both firearms, they were both found to be loaded to magazine capacity. PFC Redmond spoke to the complainant who made the call for service and identified the Arrested as the one he called about. The Arrested was then transported to the Bowie Police Station to be interviewed by Det. Wood. The Arrested was then transported to Upper Marlboro Department of Corrections to be processed.
