

REGULAR CITY COUNCIL MEETING MINUTES

MONDAY, JULY 7, 2014

CALL MEETING TO ORDER:

The Regular Meeting of the Bowie City Council was held on Monday, July 7, 2014 in the Council Chambers at City Hall. Mayor Robinson called the meeting to order at 8:07 p.m.

PLEDGE OF ALLEGIANCE TO THE FLAG:

Mayor Robinson led the Pledge of Allegiance to the Flag.

QUORUM:

In attendance were Mayor Robinson, Mayor Pro Tem Trouth, Councilmembers Brady, Gardner (Arrived 8:26p.m.), and Polangin; City Manager Deutsch, City Attorney Levan, City Clerk Hernandez, Staff, the Press, and the Public.

CITIZEN PARTICIPATION:

- 1. Leslie Mummert, representing the Environmental Advisory Committee, spoke to Council in reference to creating a Nature Exploration Area in a City park for children.

City Manager Deutsch introduced the City's new IT Director, Vanetta Pledger.

Councilmember Brady moved the approval of Consent Agenda Items: A) Approval of May 5 Meeting Minutes; B) Approval of May 19 Meeting Minutes; C) Approval of June 2 Meeting Minutes; D) Approval of June 16 Meeting Minutes; E) Approval of Resolution R-42-14 — By Two-Thirds Vote Authorizing the Waiving of Bidding Requirements to Allow for the Purchase of Eighteen Police Vehicles by Piggybacking on the State of Maryland Vehicle Bid; F) Approval of Resolution R-43-14 — Waiving the Competitive Bidding Requirements of Section 61 "Purchasing and Contracting" of the Charter of the City of Bowie to Allow the City Manager to Sign a Contract With Columbia Telecommunications Corporation for the Development of a Closed Circuit Television System for the City; G) Approval of Resolution R-46-14 — Approving Variance Application BV-4-14, a Request by David Magruder to Allow the Construction of Approximately 94 Linear Feet of Six Foot High Fencing Along Barberry Lane When, According to the Prince George's County Zoning Ordinance, Such Fencing Shall Not be More Than Four (4) Feet High, at 12625 Beechfern Lane; H) Approval of Resolution R-47-14 — By Two-Thirds Vote Authorizing the Waiving of Bidding Requirements to Allow for the Purchase of Two Electric Police Motorcycles. NEW BUSINESS:

A. Police Strategic Plan – Police Chief Nesky briefed Council on the Police Departments Five-Year Strategic Plan. Some of the actions in the plan include the hiring of new police officers, creating a new captain and lieutenant position, hiring call takers for the call center and the purchase of equipment for the call center which is estimated to open by June 30, 2015. The department will also begin the CALEA (Commission on Accreditation for Law Enforcement Agencies) accreditation process. A copy of the presentation is on file in the City Clerk's Office.

City Manager Deutsch commented that the suggestions made by the Chief Nesky on equipment, personnel and various administrative systems that he proposes to employ over the next five years, will require the Council's support during budget time. The strategic plan will be a living, working document that will be reviewed continually and will be the Chief's basis for the department's future budgets.

Council thanked the Police Chief for a superior presentation.

ADJOURNMENT:

Mayor Pro Tem Trouth moved to adjourn the City Council meeting and move into Closed Session under State Government Article, §10-508(a)(7): To consult with counsel to obtain legal advice on a legal matter. Councilmember Brady seconded the motion and it carried 5-0. The meeting was adjourned at 9:07 p.m.
