SYNOPSIS OF INCIDENT: On July 28, 2014 at approximately 2126 hours, Prince George's County Police responded to 5602 Judicial Drive in reference to a carjacking report. During their investigation it was revealed that the incident actually occurred in the parking lot in the 6200 block of Gothic Lane, Bowie, MD 20720. At this point, Bowie Police took over the investigation. The victim advised that while at his vehicle, he was approached by three suspects, two of which were armed with handguns. The suspects demanded money from the victim who stated that he only had a few dollars and his debit card on him. The suspects then ordered the victim into his champagne colored 2002 Lexus RX-300 and he was made to drive the suspects to various ATMs where they withdrew funds from the victim's account. The victim was then driven to the BP station at the intersection of Bell Station Road and Annapolis Road where the suspects dropped him off and fled the scene in his vehicle. Detective Wuthrich #051 of the Bowie Police Criminal Investigation Division responded to the scene to conduct further investigations. The area was canvassed with negative results. A neighborhood canvass for witnesses was also conducted. Nothing further at this time. The victim was not injured.
