## SYNOPSIS OF INCIDENT:

On 11/5/14 at 1840hrs, Bowie Police units responded to the 12300 blk of Kemmerton Ln in reference to a citizen armed robbery. Investigation found that the Victim had agreed to meet the Arrested at that location. The Victim was parked in his vehicle with his girlfriend talking to the Arrested. Two males approached the vehicle. One of the males, dressed in dark clothing, displayed a black handgun and pointed it at the Victim. The Suspect then stated "give me everything you got!" The Victim advised that he did not have anything. The Suspect then reached in and took the victim's I-phone from his lap. The two males and the Arrested fled west on Kenhill Drive towards London Lane with one of them riding a black BMX style bicycle. After an area canvass was conducted a male matching the clothing description of one of the suspects, and riding a BMX style bicycle, was located on the 14700 blk of London Ln. Det. Welsh of the CID unit responded and transported the victim to London Lane for an identification attempt. After a positive identification was made, the Arrested was transported to the Bowie Police station to be interviewed. The Wanted person was identified and a warrant is currently outstanding on him. The third suspect remains unidentified. The Arrested was then transported to the Corrections facility located in Upper Marlboro, where he was charged accordingly.
