#### **Environmental Policy Statement**

*We have six businesses within the Chamber that are currently on the Maryland Green Registry and are a “Green Bowie Biz.” We would like to double this number by working with our green team and City of Bowie staff. We will be hosting a mixer on April 12<sup>th</sup> with the Maryland Green Registry as an agenda item and will be hosting a Green Business Mixer on May 10<sup>th</sup>.*

### **Solid Waste Reduction and Reuse**

*The Chamber has diverted numerous large items from landfill by obtaining all of its furniture second hand. We also work to reuse boxes for storage and generate essentially no waste ourselves as a very small business. We also have much of our information online now and have moved away from paper brochures, information, etc.*

### **Recycling**

*The Chamber is located within the Kenhill Center in Bowie, which is serviced by City of Bowie Public Works for recycling. Any paper coming from our two shredders as well as all old papers are recycled and picked up. We also recycle ink cartridges with our Chamber member who benefits from recycling them.*
